

Belmont Yacht Club There & Back Race 2011

Notice of Race

1. Rules

1.1. The race will be governed by the rules as defined in *The Racing Rules of Sailing (2009-2012)*.

2. Eligibility and Entry

2.1. The race is open to all boats.

2.2. Eligible boats may enter by completing the attached form (Attachment 1) and sending it, together with the required fee, to Belmont Yacht Club, PO Box 13130, Chicago, IL 60613-0130 by July 30, 2011.

2.3. Late entries will be accepted until 2000 on Friday, August 5, 2011. There is a late entry fee of \$10.00 imposed for registration after July 30, 2011.

3. Fees

3.1. The entry fee is \$45.00 per boat until July 30, 2011. After July 30, the entry fee will be \$55.00 to include the late entry fee.

3.2. Meals are extra.

4. Schedule

4.1. Registration will take place on Friday, August 5, 2011, from 1800 until 2000 at the BYC Club Ship located at the north end of Belmont Harbor by B dock.

4.2. The Skippers Meeting will be Friday, August 5, 2011, at 2000 at the BYC Club Ship.

4.3. The first warning will be at 0750 on Saturday, August 6, 2011, with the first start at 0800.

5. **The Sailing Instructions** will be available on the Website one week before the race and at registration.

6. The Course

6.1. The diagram in Attachment 2 shows the course, the order in which marks are to be passed, and the side on which each mark is to be left. The approximate course length will be 47.1 nm.

7. Scoring

7.1. PHRF Corrected Time on Distance will be used for scoring.

8. Radio Communication

8.1. All boats will monitor Channel 69.

9. Prizes

9.1. Prizes will be awarded based on paid entries prior to July 30, 2010 for Single Handed and Double Handed as follows:

1 to 4 boats	1 Award
5 to 9	2 Awards
More than 10	3 Awards

10. Disclaimer of Liability

10.1. Competitors participate in the race entirely at their own risk. See Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

10.2. All competitors are required to complete the waiver of liability, Attachment 3.

11. Insurance

11.1. Each participating boat shall be insured with valid third-party liability insurance.

12. Overnight Mooring

12.1. All mooring arrangements must be made with Wetrec at Belmont Harbor 312-742-7673.

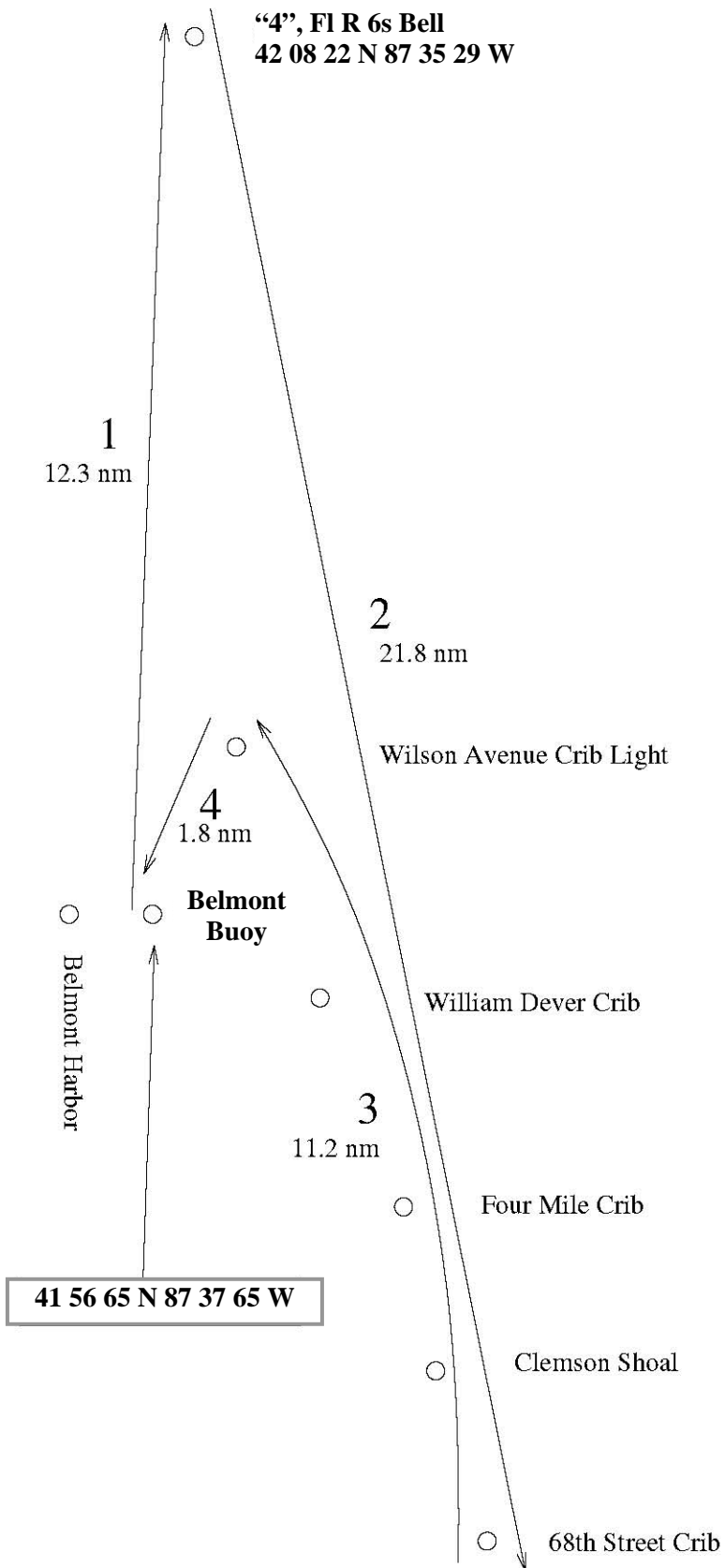
